



Subject to the following Terms and Conditions, Jacuzzi Hot Tubs in conjunction with authorized and participating Jacuzzi® dealers in the USA, is extending to US Ski & Snowboard Association ("USSA") members a \$200 off coupon the purchase of select models of Jacuzzi® hot tubs ("Coupon"). This promotional offer is subject to the following terms and conditions, and **Dealer participation is required**. ## **TERMS AND CONDITIONS OF PROMOTION**

**Promotion Dates:** The **USSA Members Coupon Promotion is valid at any authorized and participating Jacuzzi® Hot Tubs Dealer from January 2, 2018 through March 12, 2018**

Subject to these Terms and Conditions, USSA Members who purchase ("Buyer") an Eligible Hot Tub (defined below) from an authorized and participating Jacuzzi® hot tubs dealer ("Dealer") with a Coupon during the Promotion dates will receive a discount of up to \$200 off the purchase price. Buyer must initiate and complete the purchase during the Promotion Dates to be eligible, and provide evidence of valid USSA membership at the time of purchase (which may be copied by the Dealer to submit to Sponsor). Coupon expires and is not valid after the Promotion Dates. Buyer can obtain a Coupon via email or logging into their account on the USSA member website. Buyer may be asked to submit his/her contact information to receive a Coupon. By submitting contact information to receive the coupon, Buyer is agreeing to receive emails, and calls from an automatic telephone dialing system from Sponsor and/or its authorized Dealer at the number provided, including wireless, for the purpose of receiving information. This promotional offer is not valid on exchanges or returned products or in conjunction with other offers. Financing of Eligible Hot Tub is subject to Dealer offer and approval. Offer not valid on prior purchases, or purchases after the promotion dates. If Buyer cancels the purchase of an Eligible Hot Tub, or cannot take delivery of the Eligible Hot Tub on or before 60 days after the Promotion end date, Buyer forfeits the discount.

Eligible Hot Tub must be purchased from Dealer and original date of purchase by Buyer must occur between the applicable promotion dates, with the sales invoice to Buyer reflecting proper and timely application of the applicable promotion.



**General Terms:** Upon the purchase of an Eligible Hot Tub during the Promotion Dates, the Dealer must enter sales and contact information, as well as USSA member verification, into a redemption no later than 4 days after the sale. The Redemption Site will close at 11:59 p.m. Pacific Time on the fourth day after the end of the Promotion Dates. No late submissions will be accepted.

Sponsor reserves the right to audit Dealer's and Buyer's sales records to confirm eligibility for the promotion and compliance with the Rules, and Buyer consents to an audit of the records by participating in the promotion.
